**WHEREAS**, the League of California Cities (League) Annual Conference is scheduled to take place September 30 through October 2, 2015, in San Jose, and the deadline for submitting the voting delegate/alternate form to the League is Friday, September 18, 2015; and

**WHEREAS**, during their regularly scheduled City Council meeting of July 28, 2015, the City Council appointed the City's voting delegate and alternate voting delegate to the League's Annual Business Meeting to be held on October 2, 2015; and

**WHEREAS**, consistent with League bylaws, a City's voting delegate must be designated by name by City Council action taken and cannot be accomplished by individual action of the Mayor or City Manager alone;

**NOW, THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The City Council hereby designates Mayor Jorge Morales as the official voting delegate with Council Member Maria Davila as the official alternate voting delegate at the League of California Cities Annual Business Meeting on October 2, 2015.




**SECTION 3.** The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.


