**CITY OF SOUTH GATE  
LOS ANGELES COUNTY, CALIFORNIA**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE,  
ESTABLISHING A NEW SCHEDULE OF FEES FOR SERVICES FOR  
FISCAL YEAR 2015-16 AND RESCINDING RESOLUTION NO. 7602**

**WHEREAS**, the City incurs costs for providing services and is required to recover the cost of providing such services through fees and charges; and

**WHEREAS**, it is necessary to adjust and/or establish certain fees to recover the cost of providing services; and

**WHEREAS**, a duly noticed public hearing concerning this matter was held, as required by law, on July 14, 2015; and

**WHEREAS**, the proposed fees do not exceed the actual cost of providing the service;

**NOW, THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF SOUTH GATE, DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The Schedule of Fees attached hereto as Exhibit A is hereby approved and adopted and shall be adjusted annually for inflation and other factors, subject to City Council approval.

**SECTION 2.** The new fees proposed in this Schedule of Fees will be effective immediately upon adoption of this Resolution.

**SECTION 3.** Fees and charges may be waived only by the authority and approval of the City Council, with the exception of Facility Use Permit Fees, which may be waived by the Director of Parks and Recreation under criteria specified in the Administrative Guidelines adopted by the City Council on February 28, 2006.


**SECTION 4.** Penalty charges may be applied every 30 day period for nonpayment of fees as indicated in this Schedule of Fees, but may not, at any time, exceed the amount of the original fee.

**SECTION 5.** The City Manager shall have the authority to interpret the provisions of this Resolution for purposes of resolving ambiguities.


**SECTION 6.** The City Clerk shall certify to the adoption of this Resolution, which shall be effective upon its adoption.


