GATE ACCEPTING GRANT FUNDS FROM THE STATE OF
CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE
CONTROL FOR THE GRANT ASSISTANCE PROGRAM FOR FISCAL
YEAR 2013-2014**

WHEREAS, the South Gate City Council desires to undertake the Grant Assistance Program ("GAP") administered by the State of California Department of Alcoholic Beverage Control (hereafter referred to as "ABC") in the amount of \$6,100 for the project term from February 1, 2014, through June 30, 2014; and

WHEREAS, the Police Department will work in partnership with ABC Investigators to implement the objectives of the program, including sting operations, prevention and education programs that educate licensees on how they can be part of the solution to reduce alcohol related crimes; and

WHEREAS, the grant award to the City is \$6,100 which is to be used to pay sworn Police Officers' overtime expenses for Police Officers to deploy enforcement activity within the City for Fiscal Year 2013-2014;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES
HEREBY RESOLVE AS FOLLOWS:**




SECTION 2. The City Clerk shall certify to the adoption of the Resolution which shall be effective upon its adoption.


