**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE,
CALIFORNIA, AMENDING RESOLUTION NO. 7668 (SCHEDULE OF FEES) AND
RESOLUTION NO. 7779 (ESTABLISHING PASSPORT-RELATED FEES) TO
INCREASE THE PASSPORT APPLICATION ACCEPTANCE FEE FROM \$25.00 PER
APPLICATION TO \$35.00 PER APPLICATION**

WHEREAS, the Office of the City Clerk in Fiscal Year 2017/18 increased services to the residents of the City of South Gate ("City"), and therefore the office began offering Passport Services for its residents; and

WHEREAS, on July 12, 2017, the City was designated as a Passport Acceptance Facility by the U.S. Department of the State; and

WHEREAS, the South Gate City Council on September 12, 2017, adopted Resolution No. 7779 establishing new fees for passport and notary services; and

WHEREAS, the Office of the City Clerk began providing these services on September 18, 2017; and

WHEREAS, the Department of State in an effort to align the cost of providing consular related service, increased the application acceptance fee for passport books and cards from \$25.00 to \$35.00; and

WHEREAS, Chapter 2.76 (South Gate Fee Resolution) of Title 2 (Licenses-Business Regulations) of the South Gate Municipal Code, provides for establishing a Fee Resolution by the City Council for all fees and charges of the City; and

WHEREAS, the City Council adopted Resolution No. 7668, adopting a Schedule of Fees which allows for the City's recovery of costs incurred in providing services; and

WHEREAS, this Resolution will amend the Schedule of Fees to increase passport related services;

SECTION 2. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon adoption.
