PROJECT DESCRIPTION: Negative Declaration and Conditional Use Permit No. 840 to allow 396 space

off-site parking facility on a 5.79-acre property at 9208 Atlantic Avenue. The proposed parking lot will provide parking for the delivery vans and delivery van drivers working at the South Gate Amazon Distribution Center located north and east of the parking lot at 9350 Rayo Avenue. The approximately 5-acre parking lot site is within two zoning districts. The eastern portion is zoned M3 (Heavy Manufacturing) and the western portion is zoned IF (Industrial Flex). A conditional use permit is required to operate a parking lot in the IF (Industrial

Flex) zoning district.

ENVIRONMENTAL REVIEW: An Initial Study/ Negative Declaration (IS/ND) has been prepared by the City of South Gate for the proposed off site amazon parking facility at 9208 Atlantic Avenue. The City of South Gate is the Lead Agency, pursuant to the California Environmental Quality Act (CEQA) and responsible for the preparation of this document. The public comment period for the IS/ND will commence on April 28, 2020 and conclude on May 18, 2020.
