ELECTION The City Council conducted a Public Hearing and waived the reading in full and introduced Ordinance No. 2021-06-CC entitled - An Ordinance of the City Council of the City of South Gate, California, changing the date of the City's General Municipal Election from the March Statewide Primary Election cycle to the November Statewide General Election cycle, effective in 2022, and continuing thereafter in even numbered years by motion of Vice Mayor Avalos and seconded by Council Member Davila.

Carmen Avalos, City Clerk provided the staff report for this item.

Mayor Rios opened the Public Hearing. Seeing no one come forward the Mayor closed the Public Hearing.

The City Council conducted a Public Hearing and waived the reading in full and introduced Ordinance No. 2021-07-CC entitled - An Ordinance of the City Council of the City of South Gate, California, establishing the City's public, educational, and governmental programming access support fee on state-franchised video service providers operating within the City of South Gate by motion of Council Member Hurtado and seconded by Mayor Rios.

Roll Call: Mayor Rios, yes; Vice Mayor Avalos, yes; Council Member Davila, yes, Council Member Hurtado, yes and Council Member Diaz, absent

Marina Urias, Management Analyst provided the staff report for this item.

Mayor Rios opened the Public Hearing and asked if anyone in the audience wishes to speak on this item.

Adolfo Varas asked if the Spectrum channel will be providing a live broadcast of the City Council Meetings.

Cindy Esquivel asked which service customers would be charged the fee and stated that she disagrees with implementing another tax.

Ms. Urias responded that the fee is exclusively for cable subscribers with Spectrum.

Seeing no further comments the Mayor closed the Public Hearing.

Ms. Urias stated that the City currently does not video record the council meetings and only has the equipment for audio recordings. However, one of the goals of the City is to video record the meetings for cable, social media and YouTube.

Vice Mayor Avalos asked is the rescue plan funds could be used for this and clarified that the charge will only be for the cable portion of a customer's Spectrum bill.

Chris Jeffers, Interim City Manager responded that it does not appear that these funds can be used for this.

BUSINESS LICENSE

The City Council conducted a Public Hearing and adopted Resolution No. 2021-25-CC entitled - A Resolution of the City Council of the City of South Gate, California, ordering the levy and collection of assessments for Fiscal Year 2021/22 for the Parking and Business Improvement Area (known as the Tweedy Mile Business District) Business License, as permitted by the Parking and Business Improvement Area Law of 1989 (California Streets And Highways Code Section 36500 et seq.) by motion of Council Member Hurtado and seconded by Mayor Rios.

Roll Call: Mayor Rios, yes; Vice Mayor Avalos, no; Council Member Davila, recused, Council Member Hurtado, yes and Council Member Diaz, absent

Marina Urias, Management Analyst and Chris Jeffers, Interim City Manager provided the staff report for this item.

Mayor Rios asked if in the past the City has been receiving the assessment fee without going through the process.

Mr. Jeffers responded unfortunately yes.

Council Member Hurtado asked when the last time this protest vote was done.

Mr. Jeffers responded that we do not have any records of a protest vote being taken.

Council Member Hurtado asked if this is a requirement of the City or an outside agency (County or State).

Mr. Jeffers answered that State legislature passed the law in the 1980's.

Council Member Hurtado stated that he has received comments from members of the Tweedy Mile that staff hates Tweedy Mile. He finds this a disservice because it is a requirement that must be done but was not done in the past.

Council Member Hurtado requested that the City Manager set up a meeting with himself and the president of the Tweedy Mile to discuss various accusations that have come up with this process.

Vice Mayor Avalos added that she was also contacted by several of the merchants on Tweedy Mile stating that the letter was not clear on the

process of the protest and that they have reached out to the board members of Tweedy Mile with no response.

Vice Mayor Avalos would also like to be included in the meeting with Tweedy Mile.

Mayor Rios asked the City Manager to clarify the letter sent by the City.

Mr. Jeffers presented and read into the record the letter.

Mayor Rios asked for clarification on the time frame for approving this item.

Mr. Jeffers explained that if this item is not approved tonight the City would not be able to collect the \$22,000 in assessments with the renewal of the Business License due July 1st.

Mayor Rios opened the Public Hearing and asked if anyone in the audience wishes to speak on this item.

Adolfo Varas is concerned with the handling of the money within the organization and the services the Tweedy Mile provide the businesses.

Jenny Perez stated that the letter from the City was not clear. There was a request for a vote from the business members and agrees that there needs to be more transparency with the Tweedy Mile.

Evan Greenspan stated that he is disappointed that he is hearing so many untrue statements about the Tweedy Mile. Mr. Greenspan explained some of the activities provided by the board members.

Bash also spoke on the activities Tweedy Mile provides for the businesses.

Cindy Esquivel asked if this agenda item being handing out resulted in any money being taken away from Tweedy Mile.

Raul F. Salinas, City Attorney answered no.

Vice Mayor Avalos motioned to not impose the levy given the fact that there is still \$31,000 held by the Tweedy Mile District.

Seeing no one come forward the Mayor closed the Public Hearing.

Vice Mayor Avalos withdrew her motion to allow the Mr. Jeffers to report the results of the vote taken by the members of the Tweedy Mile.

Mr. Jeffers announced that there were not enough protest votes received. The City Council now has two options. They can choose to proceed with the implementation of the levy or they could choose not proceed.

Council Member Hurtado again inquired to City Manager about continuing the item due to information provided to the business owners not being clear.

Mr. Jeffers again stated that if the matter is not resolved tonight the City cannot include the levy on the business license renewal.

Due to these circumstances Council Member Hurtado motioned to approve the levy which was seconded by Mayor Rios.

Mr. Salinas asked if the item could be tabled and brought back during tonight's City Council meeting in order to confirm the vote of a quorum as only 3 members of Council participated in this item.

After the conclusion of Public Comment and Reports from Staff Mr. Salinas stated that Government Code 36936 states that whenever the City Council of a general law city is attempting to pass a Resolution it requires the majority vote of the member. In this case the majority vote of the membership would be three of the council members with two of the Council Members voting in support of the resolution then the resolution would not be approved. The vote taken by the Council for Item #4 resulted in a 2 to 1 vote which is not a majority of the membership of the City Council. The motion does not pass.

Vice Mayor Avalos requested that Item 4 be brought back for reconsideration.

Council Member Davila recused herself from participating on this item. Council Member Davila left the meeting at 10:12 p.m. for a second time.

Council Member Hurtado motioned that Item 4 be brought back for reconsideration and seconded by Mayor Rios.

REJOINED MEETING

City Council Davila rejoined the Council prior to the discussion on this matter.

COMMENTS FROM THE AUDIENCE

Virginia Johnson, 5751 McKinley Avenue spoke about the upcoming housing project at the Downey and South Gate boarder.

Bash encouraged business owners on the Tweedy Mile to volunteer and contribute their new ideas. He would also like to see the City improve the condition of the Boulevard.

Anna, South Gate Chamber of Commerce welcomed Grace Martin to the City of South Gate. She stated that the CDBG Grant for small businesses are getting close to the deadline. Many members of the Chamber of Commerce have had their businesses vandalized and she introduced the business owner of 3469-3483 Tweedy Boulevard to discuss his concerns.

Yu Chung, Tweedy Mile Business Owners explained that he has 5 buildings with broken windows and doors. He can not open for normal business because it is not safe for customers. He was notified by Tweedy Mile that there are no funds available to support his business.

Adolfo Varas spoke about Juneteenth and the LGBT Community and the ways that the City can support initiatives and resources.

Carmen Avalos, City Clerk reminded Council that Mr. Varas invited everyone to have this dialog but please be aware that two or more council members will be a violation of the Brown Act if any City business is discussed. Request that they be cautious.

Patricia Camacho, Congresswoman Barragan's Office announced that the House Commission on Transportation approved the first draft of several anticipated projects for Congressional District #24. If approved there are two projects that will benefit the City of South Gate. The two projects for South Gate are the Garfield Avenue Complete Streets and the West Santa Ana Branch Corridor.

REPORTS AND COMMENTS

FROM CITY STAFF

Chief Davis reported that the Police Department will reach out to the businesses on the Tweedy Mile and the Chamber of Commerce about the vandalism reports.

Grace Martin, Interim Director of Community Development announced that there is new planning staff member who joined the City last week and we will also be bringing on another new staff member this week.

Glenn Massey, Parks Superintendent announced that this weekend the Tree People of Greater Los Angeles will be giving away free fruit trees. There is a limit of one tree per family.

Carmen Avalos, City Clerk announced that there will be a new public records portal that will help facilitate the public with public record requests in the City Clerk's Office. Additionally, as a result of the problem we are having with the power, Ms. Jenny Perez was dropped during public comment and is now back on. Ms. Perez is requesting to be allowed to speak.

Mayor Rios responded that he would like to finish reports from staff and Council then he will open it up to Ms. Perez.

Council Member Hurtado attended an ICFA meeting. ICFA had an election for the Board Members and approve the refinancing of a manufactured home community in Palm Springs. This weekend was the bulk item and hazardous waste event with Waste Management and it was very well attended.

Council Member Hurtado spoke about the handouts regarding funding for the Tweedy Mile Association and the \$75,000 of grant money that is being administered by the Tweedy Mile Association for the businesses of South Gate.

Vice Mayor Avalos attended the bulk item and hazardous waste event with Waste Management, the grand opening of Champas Pupusas on Imperial Highway and the Southeast Water Coalition Meeting.

Mayor Rios encouraged residents to talk to their doctors and get vaccinated. The Mayor stated that MTA is moving forward on free ridership for students K-12 hopefully starting in August and September. Northgate is having their opening for the public on June 16th and they are donating \$17,000 to South Gate youth organizations and schools.

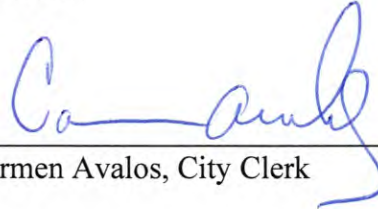
