RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE, CALIFORNIA, AMENDING RESOLUTION NO. 2021-02-CC (SCHEDULE OF FEES) APPLYING A 0.97% INCREASE TO THE RESIDENTIAL REFUSE COLLECTION AND RECYCLING SERVICES RATES AND A \$60.46 INCREASE TO THE ASSEMBLY BILL 341 NON-COMPLIANCE FEE FOR FISCAL YEAR 2021/22, EFFECTIVE JULY 1, 2021

WHEREAS, the City of South Gate ("City") must, from time to time, adjusts the schedule of fees charged for various services provided to the residents of the City;

WHEREAS, on May 10, 2005, the City Council approved Contract No. 2222, a Franchise Agreement with USA Waste of California, Inc., dba Waste Management of Los Angeles ("Agreement"), authorizing Waste Management to be the exclusive provider of refuse collection and recycling services in the City;

WHEREAS, that Agreement provides for an automatic annual increase in the rates, based on the percentage increase in the Consumer Price Index (CPI), All Urban Consumers, for the Los Angeles/Riverside/Orange County metropolitan area, as published by the United States Department of Labor, Bureau of Labor Statistics;

WHEREAS, the CPI, All Urban Consumers, for the Los Angeles/Riverside/Orange County, as published by the United States Department of Labor, Bureau of Labor Statistics no longer exists and has been replaced with the CPI, All Urban Consumers, for the Los Angeles/Long Beach/Anaheim metropolitan area, as published by the United States Department of Labor, Bureau of Labor Statistics;

WHEREAS, the CPI, All Urban Consumers, for the Los Angeles/Long Beach/Anaheim, as published by the United States Department of Labor, Bureau of Labor Statistics for the period of February 2020 to February 2021 is 0.97% which CPI shall be applied to increase the fees for residential refuse collection and recycling services;

WHERAS, the City and Waste Management acknowledge that an increase to the Assembly Bill ("AB") 341 Non-Compliance fee would encourage non-compliant customers to implement a recycling diversion program and further help the City's overall diversion rates; and

WHEREAS, a duly noticed Public Hearing concerning this matter was published in the *Los Angeles Wave* on May 6, 2021, as required by law, and the Public Hearing was held on May 25, 2021.

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES **HEREBY RESOLVE AS FOLLOWS:**

SECTION 1. The City Council does hereby declare that the above recitals are true and correct and are incorporated herein by reference.

SECTION 2. The City Council does hereby amend the residential refuse collection and recycling services fees contained in Resolution No. 2021-02-CC, Schedule of Fees, as follows:

SECTION 3. The refuse collection and recycling services fees in this Resolution shall be effective as of July 1, 2021.
