**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE
ADOPTING THE CITY'S 2012 BICYCLE TRANSPORTATION PLAN**

WHEREAS, the City of South Gate (City) is interested in promoting and supporting the use of bicycles and other alternative transportation methods within its community and by its residents; and

WHEREAS, to be eligible for Bicycle Transportation Account funds, the City must have an approved Bicycle Transportation Plan in accordance with the provisions of the California Streets and Highways Code, Chapter 517, Article 3, Section 891.2; and

WHEREAS, the City Council awarded Contract No. 2709 to Ryan Snyder Associates on January 25, 2011 to assist staff in completing a qualifying Bicycle Transportation Plan; and

WHEREAS, staff worked with a 7 member Technical Advisory Committee comprised of local residents and stakeholders who have an involvement with bicycle use in the City; and

WHEREAS, the Technical Advisory Committee conducted three public meetings between June 2011 and July 2012 to receive public comment and input and to review the Draft Bicycle Transportation Plan; and

WHEREAS, the City's 2012 Bicycle Transportation Plan (BTP) provides goals and policies related to the development of bicycle and pedestrian programs and facilities and identifies projects and project areas; and

WHEREAS, the City Council conducted a review of the Draft Bicycle Transportation Plan on September 11, 2012, and duly held a public hearing for consideration of adopting the City's 2012 Bicycle Transportation Plan on October 9, 2012; and

WHEREAS, the City's 2012 Bicycle Transportation Plan is wholly consistent with the South Gate General Plan; and

WHEREAS, the project has statutory exemption from the California Environmental Quality Act (CEQA) per California Public Resources Code Section 21083.3 (b) and CEQA Guideline Section 15183. Projects "Consistent with Community Plan or Zoning";

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby approves the City's 2012 Bicycle Transportation Plan.

SECTION 2. The Director of Public Works is hereby authorized to submit applications for the Bicycle Transportation Account fund grants.

SECTION 3. The Director of Public Works is hereby authorized to implement the BTP.

SECTION 4. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.




