WHEREAS, Marion was also a very strong supporter of Scouting's Order of the Arrow, as an Advisor he could always be counted on to be there for the scouts, Marion and his great wife, Patricia "Pat" Sarmiento along with their scout troop, supported the City of South Gate with any City activity when called upon; and

WHEREAS, Marion was also very instrumental in promoting faith among the scouts, he was very involved as a committee member on the Catholic Committee of Scouting and with the Boy Scout Council Camping Committee, he also served on the District Committee serving various positions; and

SECTION 2. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.






