**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SOUTH GATE FINDING OF PUBLIC CONVENIENCE AND
NECESSITY FOR THE SALE OF BEER AND WINE FOR OFF-
SITE CONSUMPTION AT THE JMB MARKET LOCATED AT
8501 LONG BEACH BOULAVARD**

WHEREAS, in May 16, 2013 the Department of Community Development of the City of South Gate received a request from Juan Magdaleno for a Public Convenience and Necessity Letter, in reference to an off-sale beer and wine license at the JMB Market, located at 8501 Long Beach Boulevard; and

WHEREAS, on March 3, 1987, the Planning Commission of the City of South Gate approved Conditional Use Permit No. 495 allowing the sale of beer and wine for off-site consumption at 8501 Long Beach Boulevard; and

WHEREAS, in 2011 the last valid business license expired and was not renewed (Mike's Liquor Store) and caused their Alcoholic Beverage Control license to be revoked for lack of renewal; and

WHEREAS, Conditional Use Permit No. 495 remains a valid entitlement for off-site sales at 8501 Long Beach Boulevard; and

WHEREAS, the South Gate Police Department had no objection to granting the request; and

WHEREAS, the Alcoholic Beverage Control Board (ABC) requires that the City Council declare a Public Convenience and Necessity prior to the ABC Board's approval and reissuance of a liquor license pursuant to Section 23958.4 of the Business and Professions Code;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council does hereby determine that the issuance of a liquor license to JBM Market located at 8501 Long Beach Boulevard will serve the "Public Convenience and Necessity" and will not tend to create a law enforcement problem.


SECTION 2. The City Council does hereby grant the request for Determination of "Public Convenience and Necessity" for the sale of alcoholic beverages for off-site consumption at 8501 Long Beach Boulevard.

SECTION 3. The City Council does hereby instruct the City Clerk to transmit this determination to the State Department of Alcoholic Beverage Control as the required findings under Business and Professions Code Section 23958.4.

SECTION 4. The City Clerk shall certify to the adoption of this Resolution, which shall be effective upon its adoption.






