CITY OF SOUTH GATE LOS ANGELES COUNTY, CALIFORNIA

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE DECLARING THE CITY'S INTENTION TO VACATE WRIGHT PLACE SOUTH OF THE UNION PACIFIC RAILROAD CROSSING AND WEST OF ATLANTIC AVENUE TO ITS TERMINUS AND SETTING A PUBLIC HEARING FOR APRIL 22, 2014

WHEREAS, pursuant to the provisions of the Public Street, Highway and Service Easement Vacation law (California Streets and Highway Code Section 8300, et seq.), the City of South Gate, a California municipal corporation, hereby declares its intention to vacate Wright Place from Atlantic Avenue west to its terminus in the City of South Gate, County of Los Angeles, State of California, as described in Exhibits A and B attached hereto and fully incorporated by this reference; and

WHEREAS, proceedings for such vacation are being conducted pursuant to and in conformity with Chapter 3, Part 3, Division 9 of the California Streets and Highway Code, Section 8320, et seq. ("Street Vacation Law");

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby declares its intention to vacate Wright Place south of the Union Pacific Railroad Crossing and west of Atlantic Avenue to its terminus in the City of South Gate, County of Los Angeles, State of California, more particularly described and shown in Exhibits A and B.

SECTION 2. The Planning Commission determined the proposed vacations on said streets to be consistent with the City's General Plan at its February 4, 2014 meeting.

SECTION 3. Pursuant to the California Environmental Quality Act, Public Resources Code §21000, *et seq.* and the Guidelines at Title 14, California Code of Regulations §15000, *et seq.* (together, "CEQA"), the proposed vacation is categorically exempt under Guidelines Section 15301, Class 1 (c). This exemption consists of projects including minor alterations to public facilities that involve no or negligible expansion of use and as the proposed street vacation involves no expansion of use; further, this exemption specifically applies to existing highways and streets, sidewalks and gutters, bicycle and pedestrian trails and similar facilities.

SECTION 4. Notice is hereby given that a public hearing shall be held on this proposed street vacation on April 22, 2014, at the hour of 6:30 p.m. in the City Council Chambers at City Hall, 8680 California Avenue, South Gate, California, at which time any and all interested persons may present evidence to object to the proposed vacation.

SECTION 5. The City Council hereby directs the City Clerk to cause notices of public hearing to be published pursuant to Section 8322 of the California Street and Highway Code and to be posted conspicuously along the portion of the street proposed to be vacated pursuant to Section 8322 of the California Street and Highways Code.

SECTION 6. The City Clerk shall certify to the adoption of this Resolution witch shall be effective upon its adoption.
