**A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF SOUTH GATE FINDING OF PUBLIC CONVENIENCE
AND NECESSITY FOR THE SALE OF BEER, WINE AND
DISTILLED SPIRITS FOR OFF-SITE CONSUMPTION AT
WALMART LOCATED AT 4651 FIRESTONE BOULAVARD**

WHEREAS, on December 13, 2011 the City Council of the City of South Gate approved Conditional Use Permit No. 797 allowing the sale of beer, wine and distilled spirits for off-site consumption at Walmart located at 4651 Firestone Boulevard; and

WHEREAS, the South Gate Police Department had no objection to granting this request; and

WHEREAS, the Alcoholic Beverage Control Board (ABC) requires that the City Council declare a Public Convenience and Necessity prior to the ABC Board's approval and issuance of a liquor license pursuant to Section 23958.4 of the Business and Professions Code;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES
HEREBY RESOLVE AS FOLLOWS:**

SECTION 1. The City Council does hereby determine that the issuance of a liquor license to Walmart located at 4651 Firestone Boulevard will serve the "Public Convenience and Necessity" and will not tend to create a law enforcement problem.




SECTION 4. The City Clerk shall certify to the adoption of this Resolution, which shall be effective upon its adoption.




