**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE  
ESTABLISHING A NEW SCHEDULE OF FEES FOR SERVICES FOR FISCAL  
YEAR 2014-15 AND RESCINDING RESOLUTION NO. 7557**

**WHEREAS**, the City incurs costs for providing services and is required to recover the cost of providing such services through fees and charges; and

**WHEREAS**, it is necessary to adjust and/or establish certain fees to recover the cost of providing services; and

**WHEREAS**, a duly noticed public hearing establishing a new Schedule of Fees to be charged for services and rescinding Resolution No. 7557 was held on June 10, 2014 as required by law; and

**WHEREAS**, the proposed fees do not exceed the actual cost of providing the service;

**NOW, THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The Schedule of Fees attached hereto as Exhibit A is hereby adopted and shall be adjusted annually, subject to City Council approval for inflation and other cost factors.

**SECTION 2.** The new fees provided in this Schedule of Fees will be effective immediately upon adoption of this Resolution.

**SECTION 3.** Fees and charges may be waived only by the authority and approval of the City Council, with the exception of Facility Use Permit Fees, which may be waived by the Parks and Recreation Director under criteria specified in the Administrative Guidelines adopted by the City Council on February 28, 2006.

**SECTION 4.** Penalty charges may be applied every 30 day period for nonpayment of fees as indicated in this Schedule of Fees, but may not at any time exceed the amount of the original fee.



**SECTION 5.** The City Manager shall have the authority to interpret the provisions of this Resolution for purposes of resolving ambiguities.


**SECTION 6.** The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.




