A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF SOUTH GATE FINDING OF PUBLIC CONVENIENCE
OR NECESSITY FOR THE SALE OF BEER, WINE AND
DISTILLED SPIRITS FOR OFF-SITE CONSUMPTION FOR
HOLLYDALE MINI-MART LOCATED AT 5720 IMPERIAL HIGHWAY

WHEREAS, on March 3, 2015, the Planning Commission of the City of South Gate approved Conditional Use Permit No. 554 Amendment No. 6 allowing the sale of beer, wine and distilled spirits for off-site consumption for Hollydale Mini-Mart located at 5720 Imperial Highway; and

WHEREAS, the South Gate Police Department had no objection to granting this request; and

WHEREAS, the Alcoholic Beverage Control Board (ABC) requires that the City Council declare a Public Convenience or Necessity prior to the ABC Board's approval and issuance of a liquor license pursuant to Section 23958.4 of the Business and Professions Code;

WHEREAS, on April 28, 2015, during its regular scheduled City Council meeting, the City Council considered and continued the finding of Public Convenience or Necessity to the City Council meeting of May 12, 2015;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** The City Council does hereby determine that the issuance of a liquor license to Hollydale Mini-Mart located at 5720 Imperial Highway will serve the "Public Convenience or Necessity" and will not tend to create a law enforcement problem.
