CITY OF SOUTH GATE LOS ANGELES COUNTY, CALIFORNIA

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE DETERMINING THAT EUI SEOP HAN, AKA PAUL HAN, IS INCAPACITATED WITHIN THE MEANING OF THE PUBLIC EMPLOYEES' RETIREMENT LAW AND THAT SUCH DISABILITY IS A RESULT OF INJURY ARISING OUT OF AND IN THE COURSE OF HIS EMPLOYMENT

WHEREAS, the City of South Gate (hereinafter referred to as "Agency") is a contracting Agency of the Public Employees' Retirement System; and

WHEREAS, the Public Employees' Retirement Law requires that a contracting agency determine whether an employee of such agency in which the employee is classified as a local safety member is disabled for purposes of the Public Employees' Retirement Law and whether such disability is "industrial" within the meaning of such law; and

WHEREAS, an application for industrial disability retirement of Eui Seop Han, aka Paul Han, employed by the agency in the position of Police Officer, has been filed with the Public Employees' Retirement System; and

WHEREAS, the Agency has reviewed the medical and other evidence relevant to such alleged disability;

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby finds and determines that **Eui Seop Han**, **aka Paul Han**, is incapacitated within the meaning of the Public Employees' Retirement Law for performance of his duties in the position of Police Officer with our Agency and with other California public agencies in CalPERS.

SECTION 2. The City Council finds and determines that such disability is a result of injury arising out of and in the course of employment; and further determines that such disability did occur during the performance of those portions of the employee's duties which are particularly hazardous and dangerous.

SECTION 3. Neither **Eui Seop Han, aka Paul Han,** nor the City of South Gate has applied to the Workers' Compensation Appeals Board for a determination pursuant to Section 21166 whether such disability is industrial.

SECTION 4. There is not a possibility of third party liability present.

SECTION 5. Advance Disability Pension Payments will be made. The payments will be made monthly in the amount of \$3,322.05 beginning August 1, 2015.

SECTION 6. Per the opinion of Dr. Dennis Greenberger, as contained in his report of March 25, 2014, Eui Seop Han's, aka Paul Han's, primary disabling condition arises out of his employment, and as a result he is substantially incapacitated from the performance of his usual duties as a Police Officer. The member is competent to act on his behalf in legally binding retirement matters.

SECTION 7. The City Clerk shall certify to the passage and adoption of this Resolution which shall be effective upon its adoption.
