RESOLUTION RESCINDING RESOULTION NO. 6900; AUTHORIZING SUBMITTAL OF FUNDING REQUESTS TO THE DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY (CalRecycle) FOR THE BEVERAGE CONTAINER RECYCLING CITY PAYMENT PROGRAM; AND AUTHORIZATING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS

WHEREAS, pursuant to Public Resources Code (PRC) Section 14581(a)(3)(A), also known as the California Beverage Container Recycling and Litter Reduction Act, the Department of Resources Recycling and Recovery (CalRecycle) distributes funds annually to eligible cities and counties specifically for beverage container recycling and litter cleanup activities; and

WHEREAS, the goal of CalRecycle's beverage container recycling program is to reach and maintain an eighty (80) percent recycling rate for all California Refund Value beverage containers such as aluminum, glass, plastic and bi-metal; and

WHEREAS, for many years, the City has received funding from the Beverage Container Recycling City Payment Program and utilizes the funds to provide South Gate residents opportunities to recycle beverage containers, raise awareness of South Gate's Recycling Program and help organize liter cleanup campaigns by areas such as the Los Angeles River, South Gate Parks, business districts, schools and residential neighborhoods; and

WHEREAS, CalRecycle is required to establish procedures governing the administration of the payment programs; and

WHEREAS, CalRecycle's procedures for administering payment programs require, among other things, an applicant's governing body to declare by Resolution certain authorizations related to the administration of the payment program; and

WHEREAS, on May 13, 2003 the City Council adopted Resolution No. 6900, authorizing the submittal of funding requests for the Beverage Container Recycling City Payment Program and authorizing the Director of Public Works to execute all necessary documents; and

WHEREAS, the City Council now desires to authorize the City Manager to execute all necessary documents;

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby rescinds Resolution No. 6900 authorizing the submittal of funding requests for the Beverage Container Recycling City Payment Program and authorizing the Director of Public Works to execute all necessary documents.

SECTION 2. The City Council hereby authorizes the submittal of funding request applications to CalRecycle for any and all payment programs offered.

SECTION 3. The City Council hereby authorizes the City Manager, or his/her designee, as Signature Authority to submit funding requests and all documents necessary to implement and secure CalRecycle funding and payments.

SECTION 4. This authorization is effective until rescinded by the City Council of the City of South Gate.

SECTION 5. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.
