A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE AMENDING RESOLUTION NO. 7668 (SCHEDULE OF FEES) ESTABLISHING A NEW SCHEDULE OF FEES FOR THE ENFORCEMENT OF ILLEGAL DANGEROUS FIREWORKS

WHEREAS, the City has utilized extraordinary services to address the use and possession of illegal dangerous fireworks; and

WHEREAS, it is necessary to establish certain fees to recover the cost of providing this enforcement; and

WHEREAS, a duly noticed public hearing concerning this matter was held, as required by law, on May 24, 2016; and

WHEREAS, the proposed fees are considered punitive fines and do exceed the actual cost of providing the service;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The Schedule of Fees attached hereto as Exhibit "A" is hereby approved and adopted and shall be adjusted annually for inflation and other factors, subject to City Council approval.

SECTION 2. The new fees proposed in this Schedule of Fees will be effective immediately upon adoption of this Resolution, or the effective date of Ordinance No. 2327 relating to dangerous fireworks, whichever date is later.

SECTION 3. Fees and charges may be waived only by the authority and approval of the City Council.

SECTION 4. Late charges may be applied as indicated on Exhibit "A" as indicated in the Schedule of Fees, but may not, at any time, exceed the amount of the stated fees and charges set forth in Exhibit "A."

SECTION 5. The City Manager or his/her designee shall have the authority to interpret the provisions of this Resolution for purposes of resolving ambiguities.

SECTION 6. The City Clerk shall certify to the adoption of this Resolution, which shall be effective upon its adoption.
