RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE SUPPORTING LEGISLATION THAT INCREASES HIGHER EDUCATION ACCESSIBILITY

- WHEREAS, S. 1716 has been introduced in the United States Senate and H.R. 2962 was introduced in the House of Representatives providing for free community college for eligible students; and
- WHEREAS, Congress recognizes the importance of making higher education more affordable for millions of students seeking the skills and credentials that can create a path to the middle class; and
- **WHEREAS**, in the 21st century, a high school diploma is no longer enough to lead Americans to a good job and decent quality of life; and
- WHEREAS, Congress is joining President Obama in calling on community colleges to strengthen their programs and increase the number students who graduate and for states to invest more in higher education and training; and
- WHEREAS, America's College Promise Act provides a federal match of \$3 for every \$1 invested by the state to waive community college tuition and fees for eligible students before other financial aid is applied; and
- WHEREAS, S. 1716 and H.R. 2962 ensures that community colleges offer academic credits that are fully transferable to four-year institutions in their state, or occupational training that leads to credentials in an in-demand industry; and
- WHEREAS, under the legislation, nine million students would benefit, saving a full-time community college student an average of \$3,800 in tuition each year; and
- WHEREAS, the Board of Trustees for the Los Angeles Community College District (LACCD) is requesting the California State Legislature adopt legislation that provides a similar framework to the *America's College Promise Act*, which if approved, could offer qualifying students free community college tuition; and
- **WHEREAS**, the City Council wishes to support the Board of Trustees for the LACCD in their efforts in creating avenues toward providing free community college education opportunities for all responsible students; and
- WHEREAS, the City Council wishes to support federal and state legislation that increases access and affordability for students attending community colleges;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby requests members of Congress to adopt the *America's College Promise Act* and state legislators introduce and adopt matching legislation that increases higher education accessibility.

SECTION 2. The City Council hereby authorizes City staff to communicate its request to the City's federal and state representatives.

SECTION 3. The City Clerk shall certify the adoption of this Resolution which shall be effective upon its adoption.
