A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE AMENDING THE HOURLY PAY TABLE

WHEREAS, per Council action on September 26, 2006, the hourly police officer hourly pay rate was established at Step 28-C of the Full-Time Police Officer Pay Table; and

WHEREAS, currently, the Full-Time Police Officer pay rate for Step 28-C is at \$37.53 per hour; and

WHEREAS, recently, it was brought to the attention of staff that the two hourly police officers are still at the pay rate of \$34.32 per hour; and

WHEREAS, staff was not aware that the hourly rate was tied to the Full-Time Police Officer salary rate until it was recently brought to their attention, and therefore, staff is proposing to update the Hourly Pay Table and retroactively pay what is owed to the two hourly police officers; and

WHEREAS, based on the history for the position, changes in the Full-Time Police Officer salary rate occurred on December 16, 2012, July 1, 2013, February 7, 2016, and June 26, 2016;

SECTION 1. The City Council hereby approves and adopts the proposed amended Hourly Pay Table, attached hereto as Exhibit "A."

SECTION 2. The City Council hereby also approves the following retroactive pay rates for the Hourly Police Officer position:

Effective December 16, 2012	\$33.27
Effective July 1, 2013	\$34.76
Effective February 7, 2016	\$36.12

SECTION 3. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.
