LOS ANGELES COUNTY, CALIFORNIA**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE  
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON  
MARCH 7, 2017 DECLARING THE RESULT AND SUCH OTHER MATTERS AS  
PROVIDED BY LAW**

**WHEREAS**, a General Municipal Election was held and conducted with a Special Election for Los Angeles County by the Registrar-Recorder/County Clerk of the County of Los Angeles, on Tuesday, March 7, 2017, as required by law; and

**WHEREAS**, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, the Los Angeles County Registrar Recorder/County Clerk conducted the election and canvassed the returns of the election and has certified the results to the City of South Gate on March 21, 2017 and the results are received, attached and made a part hereof as "Exhibit "A."

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE  
DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** That the whole number of ballots cast in the precincts except vote by mail ballots was 3045. That the whole number of vote by mail ballots cast in the City was 1908, making a total of 4953 ballots cast in the City.

**SECTION 2.** That the names of the persons voted for at the election for Member of the City Council are as follows:

**SECTION 3.** That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "B."

**SECTION 4.** The City Council does declare and determine that: Al Rios was elected as Member of the City Council for the full term of four years; Denise Diaz was elected as Member of the City Council for the full term of four years; Carmen Avalos was elected as City Clerk for the full term of four years; Greg Martinez was elected as City Treasurer for the full term of four years.

**SECTION 5.** The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; (5) The total number of votes given to each person.

**SECTION 6.** That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

**SECTION 7.** That the City Clerk shall attest to and certify the passage and adoption of this Resolution, which shall be effective upon its adoption.




