**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE
AMENDING SECTION 4.14 (TRAINING PAY) OF RESOLUTION NO. 6454 (SALARY
RESOLUTION AND POSITION CLASSIFICATION PLAN) TO ADD THE POLICE
RECORDS SPECIALIST POSITION TO THE LIST OF POSITIONS THAT QUALIFY
FOR TRAINING PAY**

WHEREAS, Section 4.14 (Training Pay) in the City of South Gate's Salary Resolution No. 6454 states that, "Community Service Officers, Civilian Custodial Officers and/or Police Dispatchers are paid an additional five percent (5%) of their current wages when the employee is assigned as a Trainer for new employees in the same classification;" and

WHEREAS, Section 4.14 also states, "the maximum length of training pay for a Trainer per employee is the first six (6) months after the new employee is hired and the allowable pay is only when the Trainer is actually training on an hour-for-hour basis, as authorized by the Chief of Police, or his designee;" and

WHEREAS, in the past, one of the responsibilities of the Senior Police Records Specialist position was to train new Police Records Specialists; and

WHEREAS, the Senior Police Records Specialist position was eliminated and now the current Police Records Specialists have taken on the task of training new Police Records Specialists; and

WHEREAS, the City of South Gate desires to amend Section 4.14 (Training Pay) of Resolution No. 6454 (Salary Resolution and Position Classification Plan) to add the Police Records Specialist position to the list of positions that qualify for training pay.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby amends Section 4.14 (Training Pay) of Resolution No. 6454 (Salary Resolution and Position Classification Plan) to add the Police Records Specialist position to the list of positions that qualify for training pay. The amended language of Section 4.14 is attached hereto as Exhibit "A."

SECTION 2. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.




