A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE DECLARING THE CITY'S INTENTION TO GRANT A TEN-YEAR TERM FRANCHISE TO WORLD OIL CORP., A CALIFORNIA CORPORATION, TO LAY AND USE PIPELINES AND APPURTENANCES IN, ON, ALONG, ACROSS, UPON AND UNDER THE PUBLIC STREETS, AS THE SAME NOW OR MAY HEREAFTER EXIST, WITHIN THE CITY FOR THE PURPOSE OF IN-PLANT TRANSMITTING AND DISTRIBUTING OF PETROLEUM AND RELATED PRODUCTS, FOR ANY LAWFUL PURPOSE, AND SETTING A PUBLIC HEARING FOR NOVEMBER 28, 2017, TO CONSIDER THE INTRODUCTION OF AN ORDINANCE GRANTING THE PROPOSED RENEWAL FRANCHISE AGREEMENT

**WHEREAS**, the City Council, with the adoption of Ordinance No. 2281, granted World Oil Corp., a California corporation, ("World Oil"), a five (5) year franchise to lay and use seven (7) pipelines ("In-Plant Pipelines") within the area measuring one hundred feet (100') by twenty-two feet (22') traversing across and beneath Garfield Avenue and terminating at Lunday-Thagard Company, dba World Oil Refining, 9301 Garfield Avenue ("Franchise Area") on April 26, 2011, which Ordinance expired on April 15, 2016;

**WHEREAS**, World Oil has requested, in accordance with California Public Utilities Code Section 6231, that the City of South Gate ("City") enter into a ten (10) year franchise agreement with World Oil retroactive to April 15, 2016, relative to the Franchise Area; and

**WHEREAS**, the City, pursuant to applicable federal, state and local law, is authorized to grant franchises within the City; and

**WHEREAS**, before the City can award a franchise, California Public Utilities Code Section 6232 *et seq.* require the City Council pass a resolution declaring its intent to grant a franchise and to set a public hearing at which all persons having any objection to the granting thereof may appear before the City Council and be heard thereon;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The above recitals are all true and correct.

**SECTION 2.** In accordance with Public Utilities Code Section 6232 *et seq.*, the City Council of the City declares its intent to grant a franchise to World Oil, for it to operate and maintain the Franchise Area (100'x22'), for a period of ten (10) years, commencing retroactively on April 15, 2016 and expiring on April 15, 2026.

**SECTION 3.** The terms and conditions of the franchise will be in accordance with California Public Utilities Code Section 6201 *et seq.* and will be substantially similar to Ordinance No. 2281. The proposed ordinance will set the franchise payment, the term, and the rules and requirements under which World Oil franchise will be required to operate the pipelines. A copy of the draft proposed ordinance is attached as Exhibit A to this Resolution.

**SECTION 4.** The public hearing at which the City Council of the City shall consider the proposed franchise for first reading and at which the City Council shall hear all objections and other related comments will take place on November 28, 2017 at 6:30 p.m., or as shortly thereafter as the schedule permits, in the City Council Chambers at 8650 California Avenue, South Gate, CA 90280.

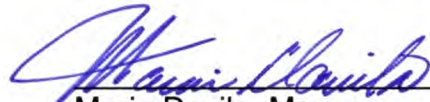

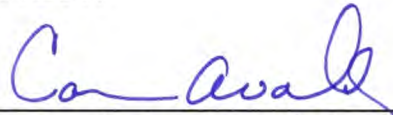
**SECTION 6.** The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.

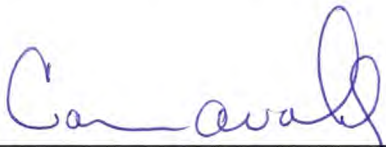
