WHEREAS, SCAG is the nation's largest metropolitan planning organization, representing six counties, 191 cities and more than 18 million residents; and

WHEREAS, SCAG undertakes a variety of planning and policy initiatives to encourage a more sustainable Southern California now and in the future; and

WHEREAS, SCAG's 2018 Regional Conference & General Assembly will be held May 2 through May 4, 2018, and requires the City Council to designate a voting delegate; and

WHEREAS, the City Council desires to designate a delegate to vote and take action during the SCAG's General Assembly Meeting;



SECTION 2. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.




