RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE APPROVING THE GARFIELD AVENUE COMPLETE STREETS AND IMPERIAL HIGHWAY GREENING PROJECT APPLICATION FOR \$2,431,112 IN GRANT FUNDS FROM THE CALIFORNIA CLIMATE INVESTMENTS URBAN GREENING PROGRAM AS REQUIRED BY THE CALIFORNIA NATURAL RESOURCES AGENCY

WHEREAS, the Legislature and Governor of the State of California have provided funds for the California Climate Investments Urban Greening Program ("Program"); and

WHEREAS, the California Natural Resources Agency ("Agency") has been delegated the responsibility for the administration of this Program, establishing necessary procedures; and

WHEREAS, said procedures established by the Agency require a resolution certifying the approval of application(s) by the applicant's governing board before submission of said application(s) to the State; and

WHEREAS, the City intends to apply for funds made available under the Program which will be reimbursed to the City in quarterly payments, contingent that the City submits quarterly reports and reimbursement requests; and

WHEREAS, the City, if selected, will enter into an agreement with the State of California to carry out the approved project ("Project") for which the City applied;

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby approves the filing of an application for the Garfield Avenue Complete Streets and Imperial Highway Greening Project.

SECTION 2. The City Council hereby certifies that the City understands the assurances and certification in the application.

SECTION 3. The City Council hereby certifies that the City will have sufficient funds to operate and maintain the project consistent with the land tenure requirements, or will secure the resources to do so.

SECTION 4. The City Council hereby certifies that it will comply with the provisions of Section 1771.5 of the State Labor Code.

SECTION 5. The City Council hereby certifies that the project will comply with any laws and regulations including, but not limited to, legal requirements for building codes, health and safety codes, disabled access laws, environmental laws and, that prior to commencement of construction, all applicable permits will have been obtained.

SECTION 6. The City Council hereby certifies that applicant will work towards the Governor's State Planning Priorities intended to promote equity, strengthen the economy, protect the environment, and promote public health and safety as included in Government Code Section 65041.1.

SECTION 7. The City Council hereby authorizes the Mayor to execute and submit the agreement and will designate the City Manager or designee to execute and submit all other documents including, but not limited to applications, payment requests, progress reports, and so on, which may be necessary for the completion of the aforementioned project(s).

SECTION 8. The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.
