## CITY OF SOUTH GATE LOS ANGELES COUNTY, CALIFORNIA

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE, CALIFORNIA, AMENDING RESOLUTION NO. 7838 (SCHEDULE OF FEES) TO APPLY A 2.51% INCREASE TO THE RESIDENTIAL REFUSE COLLECTION AND RECYCLING SERVICES RATES FOR FISCAL YEAR 2019/2020

WHEREAS, the City of South Gate ("City") must, from time to time, adjusts the schedule of fees charged for various services provided to the residents of the City; and

WHEREAS, on May 10, 2005, the City Council approved Contract No. 2222, a Franchise Agreement with USA Waste of California, Inc., dba Waste Management of Los Angeles ("Agreement"), authorizing Waste Management to be the exclusive provider of refuse collection and recycling services in the City; and

WHEREAS, that Agreement provides for an automatic annual increase in the rates, based on the percentage increase in the Consumer Price Index (CPI), All Urban Consumers, for the Los Angeles/Riverside/Orange County metropolitan area, as published by the United States Department of Labor, Bureau of Labor Statistics; and

WHEREAS, the CPI, All Urban Consumers, for the Los Angeles/Riverside/Orange County, as published by the United States Department of Labor, Bureau of Labor Statistics no longer exists and has been replaced with the CPI, All Urban Consumers, for the Los Angeles/Long Beach/Anaheim metropolitan area, as published by the United States Department of Labor, Bureau of Labor Statistics; and

WHEREAS, the CPI, All Urban Consumers, for the Los Angeles/Long Beach/ Anaheim, as published by the United States Department of Labor, Bureau of Labor Statistics for the period of February 2018 to February 2019 is 2.51% which CPI shall be applied to increase the fees for residential refuse collection and recycling services; and

**WHEREAS,** a duly noticed Public Hearing concerning this matter was held, as required by law, on June 25, 2019;

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** The City Council hereby amends the residential refuse collection and recycling services fees contained in the Schedule of Fees, Resolution No. 7838, as follows:

101 Gallon Bin	\$18.32	\$18.78
Extra Bin	\$11.78	\$12.08
64 Gallon Bin	\$16.61	\$17.03
Extra Bin	\$8.22	\$8.42

**SECTION 2.** The refuse collection and recycling services fees in this Resolution shall be effective as of July 1, 2019.

**SECTION 3.** The City Clerk shall certify to the adoption of this Resolution which shall be effective upon its adoption.
