

1 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES**
2 **HEREBY RESOLVE AS FOLLOWS:**

3 **SECTION 1.** That pursuant to the requirements of the laws of the State of California relating
4 to general law cities, there is called and ordered to be held in the City of South Gate, California
5 on Tuesday, March 3, 2020, a General Municipal Election for the purpose of electing three (3)
6 members of the City Council for the full term of four (4) years.

7 **SECTION 2.** That the City Council hereby orders the election to be consolidated with any and
8 all elections also called to be held on March 3, 2020, insofar as said elections are to be held in
9 the same territory or in territory that is in part the same as the territory of the City of South Gate
10 and requests that the Board of Supervisors of the County of Los Angeles order such
11 consolidation under Elections Code Sections 10401, 10402, and 10403.

13 **SECTION 3.** That the City Council hereby requests the Board of Supervisors of the County of
14 Los Angeles to permit the Los Angeles County Registrar-Recorder/County Clerk-Elections
15 Division to provide any and all services necessary for conducting the election and agrees to pay
16 for said services.

18 **SECTION 4** That the County Elections Division is authorized to canvass the returns of the
19 City of South Gate General Municipal Election, and the election shall be held in all respects as
20 if there is only one election.

21
22 **SECTION 5.** That the vote centers for the election shall be open as required during the
23 identified voting period from February 22, 2020 to March 3, 2020, pursuant to Sections 4007
24 and 14401 of the Elections Code.



26 **SECTION 6.** That in all particulars not recited in this Resolution, the election shall be held
27 and conducted as provided by law for holding municipal elections.

1 **SECTION 7.** That notice of the time and place of holding the election is given and the City
2 Clerk is authorized, instructed and directed to give further or additional notice of the election,
3 in time, form and manner as required by law.

5 **SECTION 8.** That the City Clerk is hereby authorized and directed to file a certified copy of
6 this Resolution with the Board of Supervisors of the County of Los Angeles and the Los
7 Angeles County Registrar-Recorder/County Clerk-Elections Division.




