

**SUBJECT:** CITY COUNCIL APPOINTMENTS TO THE VARIOUS CITY COMMISSIONS, COMMITTEES AND BOARDS

**PURPOSE:** This item was added to the Agenda at the request of Council Member Gil Hurtado to make an appointment to the Citizens Advisory Committee.

**RECOMMENDED ACTION:** The City Council will consider ratifying the appointment by Council Member Gil Hurtado of Cynthia Chavez to the Citizens Advisory Committee.

**FISCAL IMPACT:** None.

**ANALYSIS:** This appointment would be effective May 25, 2022, if approved by the City Council. The appointment must be ratified by a majority vote of the City Council.

**BACKGROUND:** Citizens Advisory Committee Member Jimmy Torres has moved from the City of South Gate and is no longer eligible to serve, therefore, a replacement is necessary to fill his vacancy. Council Member Hurtado has selected Cynthia Chavez as his appointee and the City Council will vote on this selection for ratification.

The City Council may appoint at their individual discretion, a representative to serve on the Planning Commission, Parks & Recreation Commission, Civil Service Commission and Citizens Advisory Committee. Pursuant to Ordinance No. 2286, adopted on September 27, 2011, the Tweedy Mile Advisory Board members are appointed to staggered, three-year terms. All appointments must be ratified by a majority vote of the City Council.
