The City Council will conduct a Public Hearing consider adopting a **Resolution**amending the City Schedule of Fees to increase the preferential parking permit fees and update application and review fees related to Community Development. (ADMIN SVCS)

### 5. Resolution amending Resolution No. 2021-02-CC Schedule of Fees to establish the FY 2022/23 Residential Refuse Collection and Recycling Service Fees

The City Council will conduct a Public Hearing to consider:

- c. Receiving and filing a letter from the City Manager to Waste Management approving a 5% rate increase to the residential and commercial refuse collection and recycling services for Fiscal Year 2022/23, effective July 1, 2022.
- 6. Resolution ordering the Levy and Collection of Assessments for FY 2022/23 for Parking and Business Improvement Area Business License
