Proposed Program Fees for 2022/23

Recommended Motion: Approve the Proposed Program Fee Schedule for May 13, 2022, to May 11, 2023.

Report Summary: In August of 2006, the City Council removed the recreation program fees from the City's Fee Resolution and authorized the Director of Parks & Recreation to adjust them as necessary to fit program changes. At that time, the City Council also directed staff to present their proposed fee schedule to the Parks & Recreation Commission each year. In 2021, the City Council put the program fees back in the City's Fee Resolution but instituted a "Range" for the fees that would allow for the Parks & Recreation Director to recommend fee changes.

In 2020, staff recommended a 5% increase across the board. This was to cover the cost of California AB 10 which raised the minimum wage on January 1, 2020, from \$12.00 per hour to \$13.00 per hour. This was a 9% increase in staffing costs that along with the Cost of Living in Los Angeles County also going up by 3.2%, significantly increase both materials and personnel costs for the Department.

In 2021 & 2022, the minimum wage increase went from \$13.00 per hour to \$14.00 per hour, and finally to \$15.00 per hour. No increases to class fees were implemented at those times due to Covid issues cancelling the majority of Parks & Recreation Department classes. Starting this year staff is recommending an increase of 10% per program to catch up to minimum wage increases and the current 7% inflation. Minimum increase will be \$1.00 per program. With this in mind, free swim lessons are still being offered during the summer months through our partnership with the LA 84 organization that provides the City with grant funding to provide programs for disadvantaged youth in our area. Also, "Friends of South Gate Park" the department's non-profit, still offers scholarships for classes for those that may need the assistance.

Park Facility Maintenance Division Annual Report

Recommended Motion: Motion to receive and file

Report Summary: The following is a report of what this Division has performed and accomplished during the past year.

We begin this report during the midst of the pandemic. Facilities were still closed for reservations and classes except for vaccine clinics and pandemic related events. We purchased disinfecting equipment, such as electronic handheld disinfectant sprayers, floor auto-scrubbing machines and portable pressure washing machines. These purchases expanded and improved our abilities to properly disinfect all Parks facilities. A project to apply epoxy coating on all outside restrooms at South Gate Park was completed to assist in overall cleanliness.

All main entrance doors at all South Gate Park facilities were equipped with automatic doors to comply with ADA accessibility.

Due to the reduced events and classes, staff assisted with vaccine clinics, food giveaways and delivery projects to those in need.

Once the pandemic began to slow, planning for the eventual reopening of facilities began. The Community Service Worker Program has been reopened accepting up to fifteen volunteers for facilities and more when needed to assist grounds staff. Staff schedules were changed to accommodate with the expansion of classes and reservations.

Facility staff has done a fine job during the pandemic and has been very good at transitioning from regular activities to new demands at a moments notice.
